PURPOSE ...

The nature of the business and of the purposes to be conducted and promoted by this limited liability company, is to engage solely in the following activities:

- (a) To acquire from Eagle Enterprises of Jacksonville, LLC a certain parcel of real property, together with all improvements located thereon, located at 2130 Mayport Road in the City of Atlantic Beach, State of Florida (the "Property").

(f/k/a Norwest Bank Minnesota, National Association), as Trustee for the Registered Holders of Wachovia Bank, National Association (f/k/a First Union National Bank) Commercial Mortgage Trust, Commercial Mortgage Pass-Through Certificates, Series 2000-C1, or its successors or assigns (the "First Mortgage") exists on any portion of the Property, this limited liability company shall not incur, assume, or guaranty any other indebtedness. This limited liability company shall not dissolve or liquidate, or consolidate or merge with or into any other entity, or convey or transfer its properties and assets substantially as an entirety or transfer any of its beneficial interests to any entity. For so long as the First Mortgage exists on any portion of the Property, this limited liability company will not voluntarily commence a case with respect to itself, as debtor, under the Federal Bankruptcy Code or any similar federal or state statute without the unanimous consent of all of the members of the limited liability company. For so long as the First Mortgage exists on the Property, no material amendment to these articles of organization may be made without first obtaining approval of the mortgagee holding the First Mortgage on any portion of the Property.

ARTICLE VII

CONTINUATION

To the extent permissible under applicable federal and state tax law, the vote of a majority-in-interest of the remaining members is sufficient to continue the existence of this limited liability company. If such vote is not obtained, for so long as the First Mortgage exists on any portion of the Property, this limited liability company shall not liquidate the Property without first obtaining approval of the mortgagee holding the First Mortgage on any portion of the Property. Such holders may continue to exercise all of their rights under the existing security agreements or mortgages until the debt underlying the First Mortgage has been paid in full or otherwise completely discharged.
