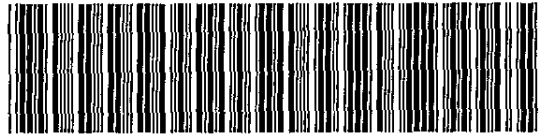

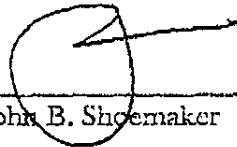
ARTICLE IV
