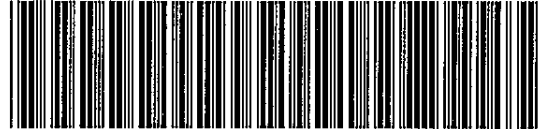

I, the undersigned, being of legal age and a natural person, do hereby subscribe and acknowledge and file the following Articles of Organization for the purpose of creating a limited liability company ("Limited Liability Company") under Chapter 608 of the Florida Statutes and the laws of the State of Florida.

**ARTICLE I**

The name of the Limited Liability Company is: PAG Clermont, LLC

**ARTICLE II**

The mailing address and street address of the principal office of the Limited Liability Company shall be PAG Clermont, LLC, c/o Sachs Sax Klein, 301 Yamato Road, Suite 4150, Boca Raton, FL 33431 but it shall have the power and authority to establish branch offices at such place or places as may be designated by the manager.

**ARTICLE III**
