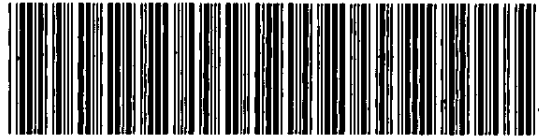




1. The name of the limited liability company is: Lake Mary Primary Care, LLC.


