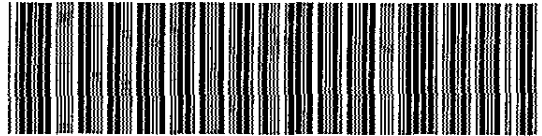

ARTICLES OF ORGANIZATION

OF

CLARK & ROBERTS, PLC

Ronald E. Clark, PA and Tance E. Roberts, PA, duly organized professional service corporations legally authorized to render the same professional services to the public that an attorney at law, duly licensed under the laws of the State of Florida, is authorized to render in the State of Florida, desiring to form a professional limited liability company in accordance with the Florida Professional Service Corporation and Limited Liability Company Act adopt the following Articles of Organization.

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this limited liability company shall be CLARK & ROBERTS, PLC, and its principal office shall be located at 501 St. Johns Avenue, Palatka, Florida, 32177, Putnam County, State of Florida, and the mailing address is the same, but it shall have the power and authority to move the principal place of business and establish branch offices at any other place or places as the members may designate.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted by the Corporation is:

(a) To engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney at law, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees, and agents who are duly licensed under the laws of the State of Florida to practice law therein.

(b) To invest the funds of the Corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional legal services.

(c) To do everything necessary and proper for the accomplishment

of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Organization or any amendment thereof, necessary or incidental to the protection and benefit of the Limited Liability Company, and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the Limited Liability Company.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the Limited Liability Company; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Limited Liability Company otherwise permitted by law.

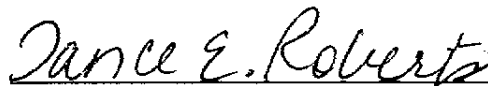

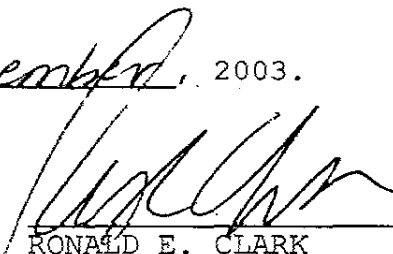

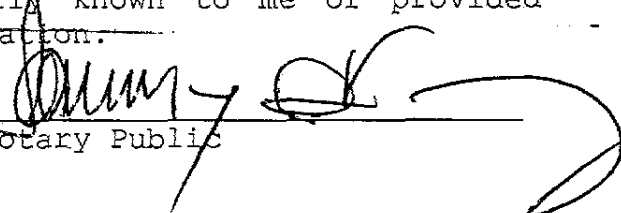
