**ARTICLES OF ORGANIZATION  
OF  
MAG BEAUTY LLC**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I**

**NAME**

The name of the limited liability company is MAG BEAUTY LLC (the "Company").

**ARTICLE II**

**ADDRESS**
