**ARTICLES ORGANIZATION FOR FLORIDA LIMITED LIABILITY  
COMPANY**

**ARTICLES I – NAME:**

The name of the Limited Liability Company is R. J. Blakeslee Irrigation LLC.

**ARTICLES II – Address:**

The mailing address and the street address of the principal office of the limited liability company.

**ARTICLES III – Duration:**

The period of duration for the Limited Liability Company shall be perpetual.

**ARTICLES IV – Management:**

All of the members, by virtue of their status as members, shall be managers of this limited liability company.

No person who is serving or who has served as a manager of the limited liability company shall be personally liable to the limited liability company or any of its members for monetary damages for breach of duty as a manager, except for liability with respect to (i) acts or omissions that the manager at the time of such breach knew were clearly in conflict with best interests of the limited liability company, (ii) any transaction from which the manager derived an improper personal benefit, or (iii) acts or omissions with respect to which the Florida Limited Liability Company Act does not permit the limitation of liability. As used herein, the term “improper personal benefit” does not include a manager’s reasonable compensation or other reasonable incidental benefit for or on account of his service as manager, employee, independent contractor, attorney or consultant of the limited liability company. No amendment or repeal of this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.




