AMENDED AND RESTATED OPERATING AGREEMENT

OF

USTLER ELECTRIC, LLC

THIS AMENDED AND RESTATED OPERATING AGREEMENT OF USTLER ELECTRIC, LLC (the "Amended and Restated Agreement" or the "Agreement") is entered into and effective as of January 1, 2006, by and between GERALD N. USTLER and JANET K. USTLER (sometimes referred to herein individually as a "Member" and collectively as the "Members").

RECITALS:

- A. The initial member of the Company, Gerald N. Ustler, formed Ustler Electric, LLC, a Florida limited liability company (the "Company"), effective January 1, 2004, by filing Articles of Organization with the Secretary of State of Florida.
- B. On January 1, 2006, Gerald N. Ustler assigned fifty percent (50%) of his Membership Interest in the Company to Janet K. Ustler.
- C. The Members desire to adopt this Amended and Restated Agreement to evidence the current Membership Interests in the Company, the Members' agreement and understanding concerning the Company, its business, assets, operations, the Members' right to manage the Company and the Members' interests in the profits, losses, capital and liabilities of the Company, in accordance with the terms set forth herein.

NOW, THEREFORE, in consideration of the mutual premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is AGREED that the statements set forth in the recitals above are true and correct and are incorporated herein and made a part hereof, and that the parties hereto agree as follows:

ARTICLE I - DEFINITIONS

- Section 1.1. <u>Definitions</u>. The following terms shall have the respective definitions set forth below unless otherwise specifically provided herein to the contrary:
- A. "Act" means the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, as amended.
- B. "Available Cash" means all cash on hand (as determined from time to time) other than cash which is (i) restricted from distribution under the terms of any agreement to which the Company is a party, or (ii) applied to pay, or added to or retained in
