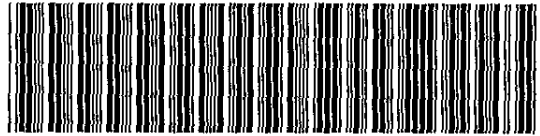



**ARTICLES OF ORGANIZATION
OF
BROOKWOOD HOMES, LLC**

The undersigned hereby certifies that he is the authorized representative of the initial manager and member who has associated himself for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. He further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE 1
NAME AND ADDRESS AND
PRINCIPAL PLACE OF BUSINESS**

The name of the limited liability company shall be Brookwood Homes, LLC, and its principal place of business and its mailing address shall be 4016 Henderson Boulevard, Tampa, State of Florida 33629 (Hillsborough County, FL).


**ARTICLE 2

To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objectives, or the furtherance of any of the powers herein set forth, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.
4. The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.
5. Nothing herein contained shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the limited liability company to carry on any business, exercise

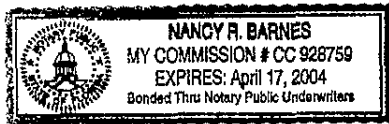




