**ARTICLES OF ORGANIZATION OF  
KATHRYN RUNCO MILLER, PLLC**

The undersigned, KATHRYN RUNCO MILLER, a natural person competent to contract, licensed to render services as an attorney at law under the laws of the State of Florida, and sole member of this professional limited liability company, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 621, *Florida Statutes*.

**ARTICLE I**

The name of the limited liability company is as follows:

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

(c) To do everything necessary and proper for the accomplishment or furtherance of any of the purposes or the attaining of any of the objectives enumerated in these Articles of Organization, or any amendment thereof, necessary or incidental to the protection and benefit of the professional limited liability company; and in general, either alone or in association with other limited liability companies, corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or objectives of the professional limited liability company.

The foregoing paragraphs shall be construed as enumerating both objectives and purposes of the professional limited liability company, and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the professional limited liability company otherwise permitted by law.

#### **ARTICLE IV - TERM OF EXISTENCE**

The limited liability company shall have a perpetual existence.

#### **ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

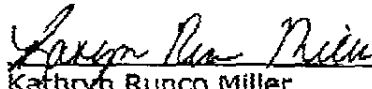
