# ARTICLES OF ORGANIZATION OF KATHRYN RUNCO MILLER, PLLC

The undersigned, KATHRYN RUNCO MILLER, a natural person competent to contract, licensed to render services as an attorney at law under the laws of the State of Florida, and sole member of this professional limited liability company, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 621, Florida Statutes.

#### ARTICLE I

The general nature of the business to be transacted by this professional limited
