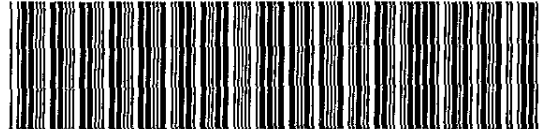



The mailing address and street address of the principal office of the company is 22051 Carr Creek Drive, Brooksville, FL 34602.




