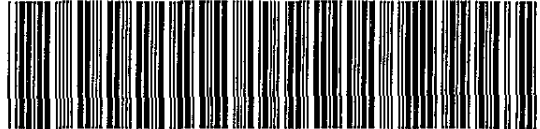

Name

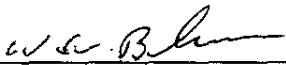

The Company shall be dissolved upon the death, insanity, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

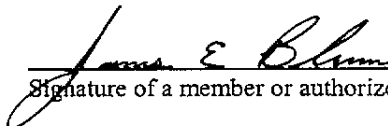
