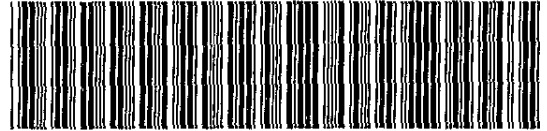

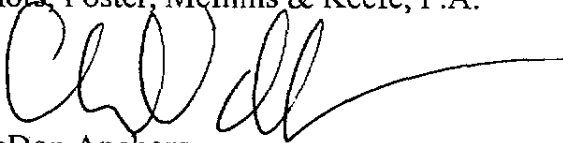

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I - NAME

The name of the limited liability company is COASTAL CONNECTION CONSULTANTS, L.L.C. (the "Company").

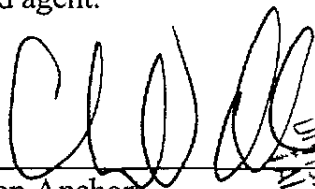
