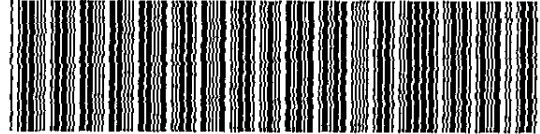

The name of the Limited Liability Company is: Robert N. Keller Construction Clean Up, LLC

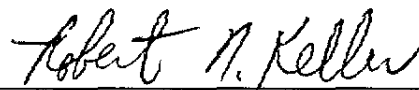
