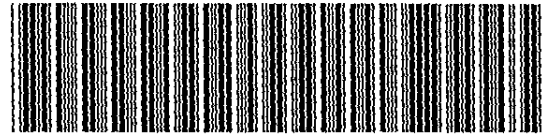

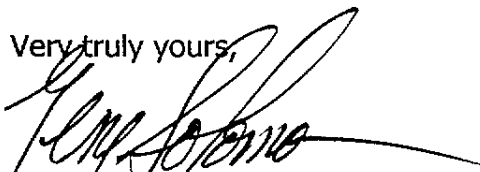

**ARTICLES OF ORGANIZATION
OF
NORTH AMERICAN REALTY GROUP, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE 1. NAME

The name of the limited liability company shall be **NORTH AMERICAN REALTY GROUP, LLC** ("Company").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the company shall be 14524 Riverside Drive, Fort Myers, Florida 33905.

ARTICLE III. DURATION

The company shall commence its existence on the date these articles of organization are filed with the Florida Department of State. The company's existence shall be perpetual, unless the company is earlier dissolved as provided in these articles of organization.

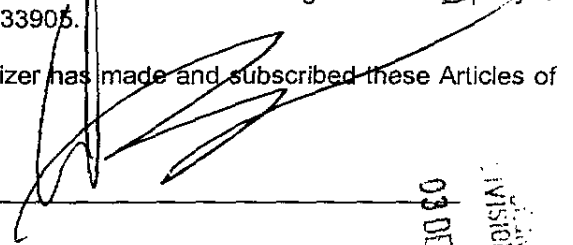
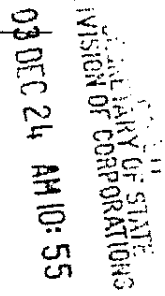
ARTICLE VIII. TERMINATION OF EXISTENCE

ARTICLE IX - MANAGEMENT

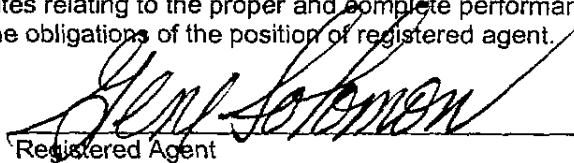
