

ARTICLES OF ORGANIZATION OF NORTH AMERICAN REALTY GROUP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE 1. NAME

The name of the limited liability company shall be **NORTH AMERICAN REALTY GROUP, LLC** ("Company").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the company shall be 14524 Riverside Drive, Fort Myers, Florida 33905.

ARTICLE III. DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual, unless the company searlier dissolved as provided in these articles of organization.

ARTICLE IV. REGISTERED OFFICE AND AGENT

ARTICLE V. ADMISSION OF NEW MEMBERS

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
