FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I - NAME

ARTICLE VII - MEMBER'S RIGHTS TO CONTINUE BUSINESS



Pursuant to the provisions of Chapter 608, Florida Statutes, this limited liability company shall begin in existence upon the filing of these Articles of Organization.


