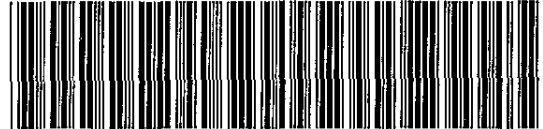

Pursuant to the provisions of section 608.411(2), Florida Statutes, this Limited Liability Company adopts the following Articles of Amendments to its Articles of Organization:

FIRST: Article 5 of the Articles of Organization provides:

The general purpose for which the Company is organized is to provide a half way house for women and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

SECOND: Article 5 shall be amended to state:



FIFTH: This amendment shall be effective upon the filing with the Secretary of State of Florida.
