

- IV REGISTERED OFFICE AND AGENT. The name of the registered agent of the Company in the State of Florida is Kevin I. Downey. and the street address of the registered office of the Company is 2631 N.W. 41st Street, Suite B, Gainesville, Florida 32606.
- V CAPITAL CONTRIBUTIONS. The members of the Company will contribute to the capital of the Company in cash or property. Each member may make additional capital contributions to the Company upon the unanimous consent of all the members.
- VI ADMISSION OF NEW MEMBERS.
