

ARTICLES OF ORGANIZATION OF
MCDADE & ASSOCIATES, LLC.

ARTICLE I

Name

The name of the limited liability company ("Company") is **MCDADE & ASSOCIATES, LLC.**

ARTICLE II

Address

Indemnification



CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE


