**ARTICLE 1 - NAME**

The name of the limited liability company shall be GET DIGITAL INSTALLATIONS, LLC, (hereinafter, "Company").

**ARTICLE 2 - PRINCIPAL OFFICE**

The address of the principal office of this Company shall be 9005 Adamo Drive, Tampa, Florida 33619 and the mailing address shall be the same.

**ARTICLE 3 - EFFECTIVE DATE**

These Articles of Organization shall be effective January 1, 2004.

**ARTICLE 4 - DURATION**

**ARTICLE 12 - REGISTERED OFFICE AND REGISTERED AGENT**


