**ARTICLE 1 - NAME**

The name of the limited liability company shall be GET DIGITAL CUSTOM CABINETRY, LLC, (hereinafter, "Company").

**ARTICLE 2 - PRINCIPAL OFFICE**

These Articles of Organization shall be effective January 1, 2004.


