- 3. The Member of the Company is authorized and directed to file with the Florida Secretary of State the Articles of Dissolution as signed by the Member of the Company.
- 4. The Member is authorized and directed to pay all such fees and taxes and to do or cause to be done such further acts as would be necessary and proper in order to effectuate the dissolution of the Company, and to effectuate fully the purposes of the foregoing resolutions.
- 5. The Company as soon as practicable shall distribute to the Member the assets of the Company, if any, in dissolution thereof.
