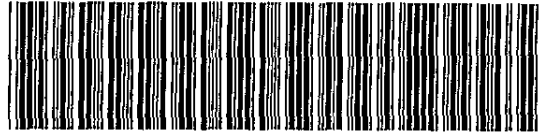

ARTICLES OF ORGANIZATION

OF

BOB ROSENDE MINOR HOME REPAIRS L. L. C.

1. NAME. The name of this limited liability company is set forth above.
2. PURPOSE AND POWERS. This company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Florida law.  - A. The initial amount of cash or property to be initially contributed by each of the members of the company is as follows: Bob Rosende, \$100.00
 - B. The company's profits and losses shall be allocated among the members in accordance with the regulations of the company.
 - C. All members of the company shall be entitled to vote on matters relating to the company. Each members vote shall be weighted in accordance with the regulations of the company.
