ARTICLES OF ORGANIZATION OF SAND LAKE REALTY VENTURES I, LLC

The undersigned authorized representative hereby executes these Articles of Organizations ("Articles") for the purpose of forming a limited liability company in accordance with the Tavis of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:
