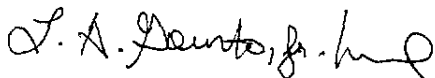

NAME

The name of this limited liability company is DPI Marine Products, LLC.

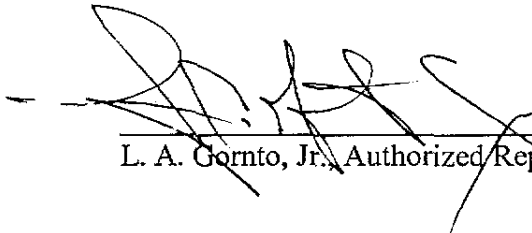

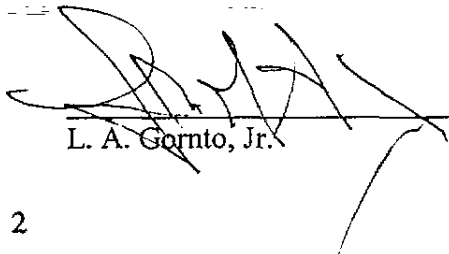
