ARTICLES OF ORGANIZATION OF NORTHEAST PAINTERS, LLC

(A Limited Liability Company)

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State Of FLORIDA, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following articles shall be the charter and authority for the conduct of business of such limited liability company.

ARTICLE I. NAME

The name of the limited liability company shall be NORTHEAST PAINTERS, LLC.

ARTICLE II. PURPOSES & POWERS

The general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, in addition to those authorized by the laws of the State Of FLORIDA, and the powers of the limited liability company, shall be as follows:
