ARTICLES OF ORGANIZATION OF CRAZY J'S PAWN SHOP, L.L.C. AND DESIGNATION OF REGISTERED AGENT

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: Crazy J's Pawn Shop, L.L.C. (the "Company").
