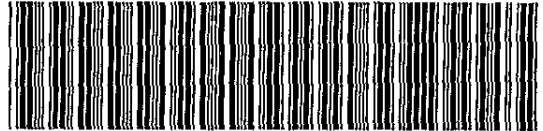

**ARTICLES OF ORGANIZATION
OF
KEVIN WARRICK TOURNAMENT GOLF, LLC**

The undersigned, being the duly authorized Organizer of the Limited Liability Company hereby being formed under the Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for the Limited Liability Company.

FIRST: The name of the Limited Liability Company is:

Kevin Warrick Tournament Golf, LLC

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized for the purposes of its' Members-Sponsors providing funds to Kevin Warrick for the purposes of enabling Kevin Warrick to participate in professional golf tournaments, all in accordance with the Operating Agreement of the Limited Liability Company as adopted by its Member-Sponsors.

FOURTH: The mailing address and street address of the organizer and of the initial registered office of the Limited Liability Company in Florida is 308 South Jefferson Street, Pensacola, Florida 32502, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Edsel F. Matthews, Jr., Attorney At Law.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

SIXTH: The Limited Liability Company will be operated by the Manager, as appointed by the Members. The name and address of the initial Manager is Edsel F. Matthews, Jr., 308 South Jefferson Street, Pensacola, Florida 32502.

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) initially contributed to the Limited Liability Company, as its initial capital, by the Members is \$60,000.00. The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests, in the ratio that each Members' contribution relates to the total contribution.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as may hereafter be agreed by the unanimous vote of the Members in accordance with the Limited Liability Company's Operating Agreement. No additional capital contributions have been agreed to by the Members at this time.

NINTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, consistent with the terms and conditions of the Limited Liability Company's Operating Agreement.

TENTH: The remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

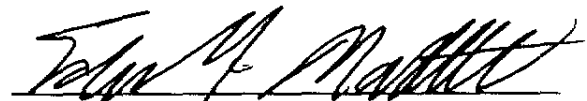

TWELFTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.

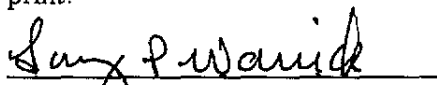
