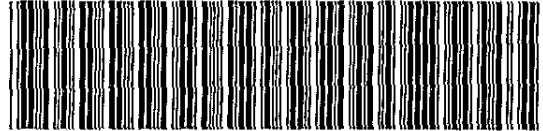



ARTICLE I

Name

The name of the limited liability company ("Company") is **TYREL J. MULLINS, LLC.**

ARTICLE II

Address

The mailing address of the Company's principal office is 23 Aviles Drive, St. Augustine, Florida 32084.

ARTICLE III

Registered Agent and Office

The name of Company's initial registered agent in Florida is Tyrel J. Mullins. The address of Company's registered office in Florida is 23 Aviles Drive, St. Augustine, Florida 32084.

ARTICLE IV

Management

The Company is to be managed by the members. Each managing member is identified as follows:

ARTICLE V

Admission of New Members

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE VI

Continuation of Business

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE VII

Indemnification


To the greatest extent not inconsistent with the laws and public policies of Florida the Company will indemnify, as a matter of right, any Member made a party to any proceeding because he or she is or was a Member, against all liability incurred by such individual in connection with any proceeding; provided that such individual has met the standard of conduct for indemnification set forth under Florida law

ARTICLE VIII

Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the members.
