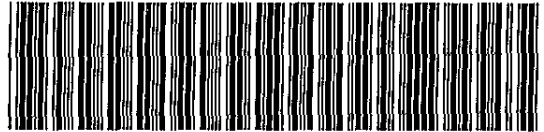

The undersigned shall own 100% of the Limited Liability Company.

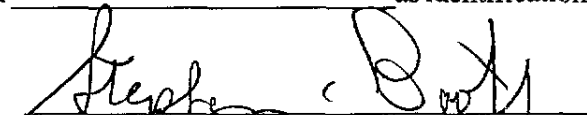
