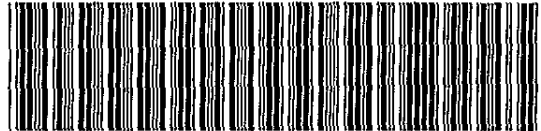

The business of the Company shall be managed by its Managing Member. The name and address of the Managing Member is set forth in Article V above.




