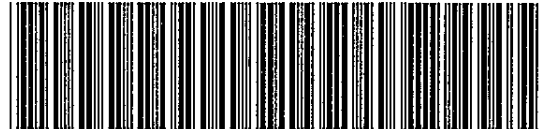



ARTICLES OF ORGANIZATION
OF

The undersigned, James J. Taylor Jr., who is the authorized representative of the below-identified limited liability company, and of the members thereof, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

ARTICLE I -- NAME

The name of the limited liability company shall be **Cedar Bay Outdoor Furniture LLC** ("the **Company**").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company is 8491 Nittany Drive, Melrose, Florida 32666.

ARTICLE III -- DURATION




