

## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF CEDAR BAY OUTDOOR FURNITURE LLC

Cedar Bay Outdoor Furniture LLC, a Florida limited liability company ("the Company"), by and through James J. Taylor Jr., who is the authorized representative of the Company, and of the members thereof, pursuant to Florida Statutes Section 608.411, files these Articles of Amendment to the Articles of Organization of the Company, which were filed with the Florida Department of State on December 22, 2003 (Document Number L03000057160).

The following amendment was adopted by the members of the Company on March 8, 2004. The number of votes cast for the amendment by the members was sufficient for approval.
