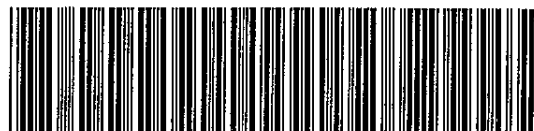



ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: DEE'S MOBILE DETAILING, LLC.

ARTICLE II -- ADDRESS

The street address of the principal office and mailing address of this company is 801 Cherokee Trail, Lakeland, Florida 33803.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date, if specified. 



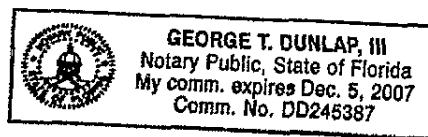
