ARTICLES OF ORGANIZATION

OF

DEE'S MOBILE DETAILING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, <u>Florida Statutes</u>, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: DEE'S MOBILE DETAILING, LLC.

ARTICLE II -- ADDRESS

The street address of the principal office and mailing address of this company is 180 Cherokee Trail, Lakeland, Florida 33803.
