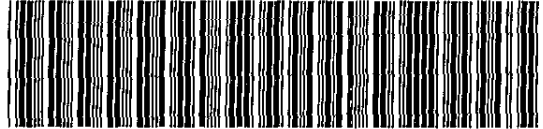



Operating Agreement and Regulations

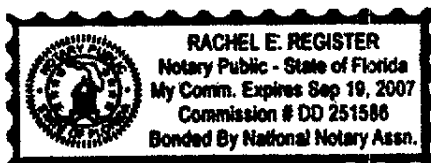


