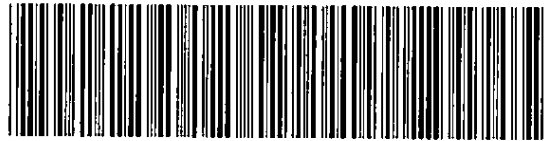

1. They are the current Managing Member and Secretary of SUNGOLD, LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on December 31, 2003.
