

The merger shall become effective as of midnight on December 31, 2009.





The following plan of merger is submitted in compliance with § 608.438, F.S.

**ARTICLE I – SURVIVING LIMITED LIABILITY COMPANY**

The name of the surviving limited liability company is 12K, LLC, which was formed under the laws of and is subject to the jurisdiction of Florida.

**ARTICLE II – MERGING LIMITED LIABILITY COMPANY**

The name of the merging limited liability company is CONNEMARA INVESTMENT COMPANY, LLC, which was formed under the laws of and is subject to the jurisdiction of Florida.

**ARTICLE III – TERMS OF MERGER**

The merger shall be effective as of midnight on December 31, 2009 (the "Effective Time"). At the Effective Time, CONNEMARA INVESTMENT COMPANY, LLC ("CIC") shall be merged with and into 12K, LLC ("12K"), with 12K being the surviving entity. The separate corporate existence of CIC shall cease at the Effective Time, and all assets, liabilities, rights, privileges and franchises of CIC shall inure to 12K.

**ARTICLE IV – CONVERSION OF MEMBERSHIP INTERESTS**

At the Effective Time, the membership interests shall be converted as follows:

- (a) Each membership interest of CIC issued and outstanding at the Effective Time shall cease to be outstanding and shall be converted into membership interests in 12K.

(b) All membership interests of 12K issued as of the Effective Time shall remain effective.
