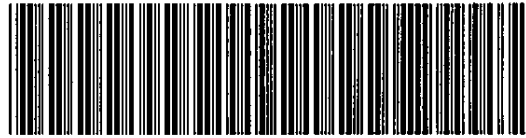

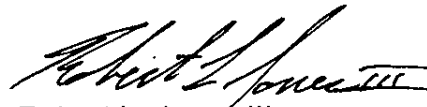

The merger shall become effective as of filing this Certificate of Merger with the Florida Secretary of State (the "Effective Time").

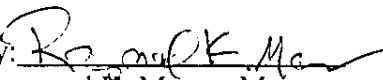

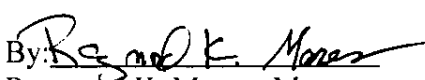

The following plan of merger is submitted in compliance with § 608.438, F.S.

**ARTICLE I – SURVIVING LIMITED LIABILITY COMPANY**

The name of the surviving limited liability company is 12K, LLC (Document Number L03000057369), which was formed under the laws of and is subject to the jurisdiction of Florida.

**ARTICLE II – MERGING LIMITED LIABILITY COMPANY**

The name of the merging limited liability company is CONNEMARA MOTORS, LLC, Document Number L06000083080) which was formed under the laws of and is subject to the jurisdiction of Florida.

**ARTICLE III – TERMS OF MERGER**

The merger shall be effective as of the date of filing of the Certificate of Merger with the Florida Secretary of State (the "Effective Time"). At the Effective Time, CONNEMARA MOTORS, LLC ("CM") shall be merged with and into 12K, LLC ("12K"), with 12K being the surviving entity. The separate corporate existence of CM shall cease at the Effective Time, and all assets, liabilities, rights, privileges and franchises of CM shall inure to 12K.

**ARTICLE IV – CONVERSION OF MEMBERSHIP INTERESTS**

At the Effective Time, the membership interests shall be converted as follows:

- (a) All membership interests of CM issued and outstanding at the Effective Time shall cease to be outstanding.

(b) All membership interests of 12K issued as of the Effective Time shall remain effective.
