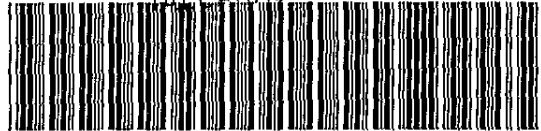

The name of the limited liability company shall be Jennyany, LLC ("company").


ARTICLE II - ADDRESS

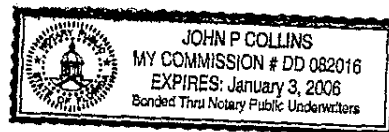
