**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF ORGANIZATION  
OF  
TEMPUS PR HOLDINGS, LLC**

Pursuant to the requirements of Section 608.411, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Organization of Tempus PR Holdings, LLC (the "Company"), which Company was organized under the laws of the State of Florida on January 2, 2004:

1. Article I of the Company's Articles of Organization is hereby amended by deleting in its entirety the existing Article I and replacing it with the following:

**"ARTICLE I**

**Name and Duration**

The name of this Limited Liability Company is WVO Puerto Rico, LLC (hereinafter referred to as the "Company"). The duration of the Company shall commence upon the filing of these Articles of Organization and shall be perpetual."

2. All other provisions of the Company's Articles of Organization shall remain in full force and effect, unaltered except as expressly provided above.

3. The foregoing amendment to the Articles of Organization was adopted by the sole Member of the Company on the 14 day of January, 2004.
