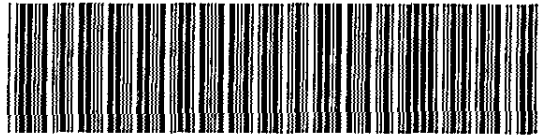

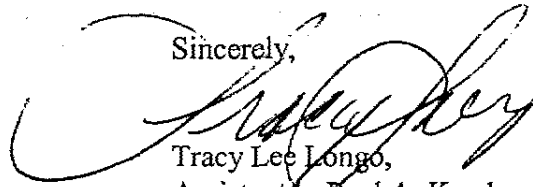

**ARTICLES OF ORGANIZATION
OF
LUCK STAR ASSOCIATES, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I
NAME**
