ARTICLES OF ORGANIZATION OF 2135 APTS, LLC

AND CONTRACTOR OF THE PART OF The undersigned certifies that he is executing and filing these Articles for the purpose of forming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. I further declare that the following Articles shall serve as the Charter and authority for the conduct of the business of the Limited Liability Company.

<u>ARTICLE I</u> NAME AND PRINCIPAL OFFICE
