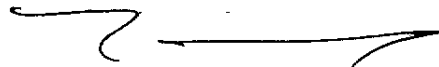

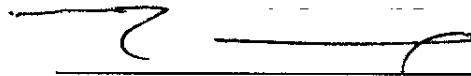

(A) to transact or carry on any and all lawful business for which Limited Liability Companies may be organized under the Florida Limited Liability Company Act,

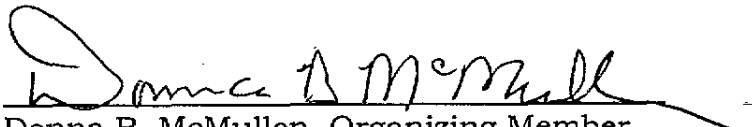
(B) to acquire, own, use, lease, convey, and otherwise use or dispose of and deal in real or personal property or any interest in such property,

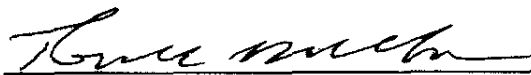
(C) to do such other acts as are incidental to the foregoing or desirable in order to accomplish the purpose for which the limited liability company was formed, and
