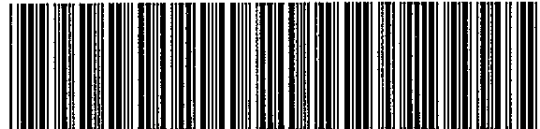

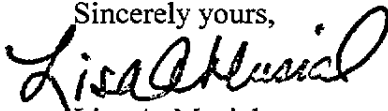

**ARTICLES OF ORGANIZATION
OF
COIA HOMES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Coia Homes, LLC. ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 1828 SE 11th Terrace, Cape Coral, Florida 33990.

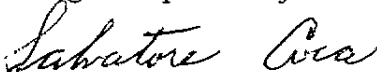
ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

ARTICLE IV - REGISTERED AGENT, OFFICE AND AGENT'S SIGNATURE

The name and street address of the registered agent of the company in the state of Florida are Salvatore Coia, 1828 SE 11th Terrace, Cape Coral, Florida 33990.

ARTICLE V - MANAGEMENT

The company is to be managed by one manager and is, therefore, a manager - managed company.

ARTICLE VI -- CAPITAL CONTRIBUTIONS

The Managing Member of the company shall contribute to the capital of the company the cash or property set forth in Exhibit "A".

ARTICLE VII -- ADDITIONAL CAPITAL CONTRIBUTIONS

If the Managing Member allows additional members to join as Interest Holders of the company, no additional members shall be required to contribute any additional capital to the company.

ARTICLE VIII -- ADMISSION OF NEW MEMBERS


This company shall only be comprised of the Managing Member, unless otherwise decided by the Managing Member. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the *management of the business and affairs of the company* or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE IX -- TERMINATION OF EXISTENCE

The company shall be dissolved on the death, bankruptcy, or dissolution of the managing member, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there are at least two remaining members.
