**ARTICLES OF ORGANIZATION  
OF  
TREASURE COAST NUCLEAR IMAGING, LLC**

1. Name. The name of this limited liability company is **TREASURE COAST NUCLEAR IMAGING, LLC**, a Florida limited liability company (the "Company").

2. Duration. The Company shall be effective upon the filing of these Articles and shall thereafter have perpetual existence.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 1265 36<sup>th</sup> Street, Vero Beach, Florida 32960.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Gary Walker. The street address of the initial registered agent of the Company is 100 South Ashley Drive, Suite 1500, Tampa, Florida 33602.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. Management of the Company. The Company shall be member-managed.


