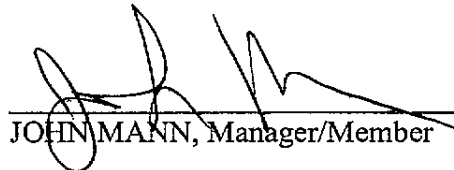
ARTICLE VII-INDEMNIFICATION

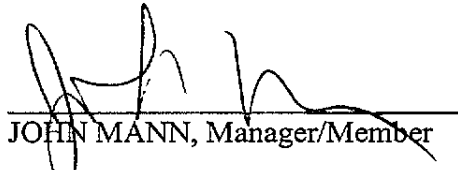
