# ARTICLES OF ORGANIZATION OF PHILLIP E. SHEA CONSTRUCTION, LLC, a Florida limited liability company

#### ARTICLE I

#### NAME

The name of this limited liability company is PHILLIP E. SHEA CONSTRUCTION, LLC.

#### **ARTICLE II**

#### **PURPOSE**
